...they are more likely to enjoy a range of interconnected human rights, including adequate standard of living and protection from forced eviction.














Why women need HLP rights?

...they are more likely to have the financial security they need, household welfare increases, decent family living conditions increase, and children have better chances to be educated.













Why women need HLP rights?

...their autonomy and self-determination increase, improving their lives and their ability to plan for old-age support.













How to increase women's access to HLP rights?

To increase women's access to housing, land and property rights in Lebanon...

Protect women's land rights at the time of marriage by promoting the inclusion of joint marital property in the national legal and administrative frameworks.













How to increase women's access to HLP rights?

To increase women's access to housing, land and property rights in Lebanon...

Protect women's inheritance rights by combating and regulating renunciation practices through the provision of necessary information, financial and legal aid, and practical support to enable women claiming their inheritance rights in courts.













How to increase women's access to HLP rights?

To increase women's access to housing, land and property rights in Lebanon...

Raise awareness among decision makers on the economic and social values of women's work; this will assist them in understanding the benefits they, and their families, will enjoy by guaranteeing women's equal access to and control over land.













How to increase women's access to HLP rights?

To increase women's access to housing, land and property rights in Lebanon...

Help women identify different land tenure options and how to access them, and provide information on financial and legal aid,

and practical support through existing legal aid centres that provide support to women's HLP issues to enable them to claim their rights in courts or alternative dispute resolution systems.

Amend discriminatory laws that hinder women's access to land, such as the Nationality Law, and develop and reform policies and laws to be gender responsive.

Promote the alignment of national policies and laws with international human rights frameworks protecting women's land and property rights.













How to increase women's participation in land-related processes?

To empower women and increase their participation in decision making...

Raise women's awareness and understanding of housing, land and property rights, so that they are better able to claim them and engage in land and HLP-related processes.















How to increase women's participation in land-related processes?

To increase women's empowerment and participation in decision making...

Promote and develop the capacities of women and women's associations by guaranteeing their participation in land-related processes and disputes to ensure that women's grievances are addressed during negotiations.













How to increase women's participation in land-related processes?

To empower women and increase their participation in decision making...

Collect and analyse sex-disaggregated data on land administration processes, land use patterns, and issues faced by women in accessing land and other land-related dynamics to guide reforms and decision-making.

Advocate for law reforms that allow Lebanese wives who are married to non-Lebanese nationals to pass their land and property assets to their children without abiding by the acreage requirements.

Draft out appropriate laws that ensure equal inheritance rights between women and men.
