
Capacity and Knowledge Development on Land Governance in the Arab Region AoC

UTI/GLTN (AoC) Main Components

1- Capacity Assessment on Land Governance Regarding the **land governance** in **Arab countries NOT covered** by the capacity needs assessment undertaken **by the NELGA North Africa node.** The focus will be on ME & Gulf Countries.

2- Conduct Two Capacity Development Events Gender-Responsive land tools Partners tools and approaches that are relevant for contributing to Good Land Governance in the region.

4- Translation and Adaptation

2- Conduct Two Capacity Development Events

An Induction, Capacity Development and Planning Workshop: New Partnerships and Perspectives for the Arab Land Initiative: From 02-06 February 2020

An induction workshop for capacity development and planning for the Arab Land Initiative has successfully taken place in Cairo, Egypt. It was the first event that brought together the newly contracted partners implementing the different areas of work of the BMZ-funded "Arab region program on good land governance in support to inclusive development, peace and stability". The event was hosted by the Urban Training & studies Institute (UTI) in collaboration with GLTN and UN-Habitat at the Housing and Building National Research Center (HBRC).



3- Establishment and **Management** of a **Research Innovation Fund**

17 Research Grants Awarded through the Research Innovation Fund, July 2020

A call for proposal for research grants was led by (UTI/HBRC), in cooperation with (GLTN) with the financial support from (BMZ). UTI received eighty (80) submissions covering the twelve main cross-sectorial land governance themes proposed in the call. The selection criteria were: clarity of the research objectives, soundness of the hypothesis, relevance of the case studies, credibility of the methodology, validity of the references, innovation potential, and transferability of the expected results.

Due to the good quality and very competitive applications received, the review committee **decided to** increase the awarded applications from 8, as initially planned, to 17 grantees.

Out of the selected research proposals, 12 are in English; 3 in Arabic and 2 in French

- **Translated materials** into Arabic on different land related issues, enriching the Arabic Library.
- Build on existing regional networks of expertise in land governance (GLTN, NELGA, ILC, AUS, HIC, etc.)
